BY-LAW NO. 05-284

To Amend Bylaw No. 01-218, as amended, Being a Bylaw To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the <u>Municipal Act</u>, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the <u>Highway Traffic Act</u>;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Haymarket South 92 ft. east of Hughson to 123 ft. easterly Anytime"

and by adding to Section "E" thereof the following items, namely:

"Haymarket South from 36m west of John to 43m westerly Anytime

Herkimer South from 37.4m east of Bay to 4m easterly Anytime

Herkimer South from 54.6m east of Bay to 26.8m easterly Anytime"

2. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:
