CITY OF HAMILTON

BY-LAW NO. 06-025

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

"Olgilvie	East	From 21.6m north of Hatt to 5m northerly	Anytime"
-----------	------	---	----------

and by deleting from to Section "E" thereof the following items, namely:

"Avondale	West	Mons to the Canadian National Railway Main Line	Anytime
-----------	------	--	---------

Macklin	East	Main to Northerly End	Anytime
---------	------	-----------------------	---------

Rockway	North & West	from 233 feet east of Parkwood to the northerly end	Anytime"
---------	-----------------	--	----------

and by adding to Section "E" thereof the following items, namely:

"Avondale	West	Mons to 123.2m northerly	Anytime
Borodino	North	From 23.4m west of Essling to 9.3m westerly	Anytime
Macklin	East	Main to 245.4m north of Dufferin	Anytime
Macklin	East	From 294.1m north of Dufferin to Northerly End	Anytime
Rockway	North & West	from 65.1m east east of Parkwood to 47.2m easterly and northerly	Anytime"

2. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Allan	North	from 67.7m west of Cope to 6.1m westerly	Anytime
Britannia	South	Frederick to Province	Anytime
Strathearne	West	commencing 438 feet south of Barton and extending 23 feet southerly therefrom	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Mary	East	From 36.8m south of Robert to 7.5m southerly	Anytime
Smith	West	From 171.3m south of Barton to 5.6m southerly	Anytime"

To Amend By-law No. 01-218, as amended,
Being a By-law to Regulate On-Street Parking

3. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Macklin	East	280 ft.	442 ft. north of Dufferin	7:00 a.m. - 6:00 p.m. Monday to Saturday
Macklin	East	160 ft.	805 ft. north of Dufferin	7:00 a.m. - 6:00 p.m." Monday to Saturday


and by adding to Section "E" thereof the following items, namely:

"Macklin	East	From 134.7m north of Dufferin to 85.3m northerly	7:00 a.m. to 4:00 p.m. Monday to Friday
Macklin	East	From 245.3m north of Dufferin to 48.8m northerly	7:00 a.m. to 4:00 p.m." Monday to Friday

4. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
5. This By-law shall come into force and take effect on the date of its passing and enactment.
