CITY OF HAMILTON

BY-LAW NO. 08-044

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Pearl	East	from 37.9m north of Tuckett to 56.5m northerly	3 hr	8 am – 6 pm	Mon – Fri"

and by adding to Section "E" thereof the following item, namely:

"Pearl	East	from 41.6m north of Tuckett to 21.8m northerly	3 hr	8 am – 6 pm	Mon – Fri"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Kettlepoint	South	from 55.5m east of Piano to 21.1m easterly			Anytime

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Paling	West	commencing at a point 117 feet north of Vansitmart to a point 23 feet northerly therefrom	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Chestnut	East	from 203.5m north of Cannon to 6m northerly	Anytime
Gertrude	North	from 20.2m west of the extended west curb line of Lyndhurst to 4.5m westerly	Anytime"

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Sherwood Rise	North	Princeton to 20m westerly	Anytime"

5. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

6. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Sherwood Rise	North	160 feet east of High to 184 feet easterly	7:00 a.m. to 6:00 p.m. Monday to Saturday

and by adding to Section "E" thereof the following items, namely:


"Erindale	East	from 33.5m north of Dundonald to 9.1m northerly	7:00 a.m. to 5:00 p.m. Monday to Friday

7. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.

8. This By-law shall come into force and take effect on the date of its passing and enactment.
