## **CITY OF HAMILTON**

### **BY-LAW NO. 08-153**

**To Amend By-law No. 01-215, being a By-law to Regulate Traffic  
and Bylaw No. 01-218, being a By-law to Regulate On-Street Parking,  
each as amended.**

**WHEREAS** Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

**AND WHEREAS** it is necessary to amend By-law No. 01-215, as amended and No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Stop Signs) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"Glen Castle	Eastbound	Mount Albion
Golfcrest	Eastbound	Mount Albion
Kingswood	Eastbound	Mount Albion"

2. Schedule 2 (Through Highways) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Mount Albion Road	southerly limit of King Street	northerly limit of Mud" Street
--------------------	-----------------------------------	-----------------------------------

and by adding to Section "E" thereof the following item, namely:

"Mount Albion                      southerly limit of Lawrence      southerly limit of"  
Greenhill

3. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Mount Albion	West	King to Kingswood	Anytime
Mount Albion	East	Mud to 2000 ft. northerly	Anytime
Mount Albion	West	from 165 feet south of Glencastle to Mud	Anytime
Mount Albion	East	Entrance Glendale Golf Club to King	Anytime
Mount Albion	West	Kingswood to 165 feet south of Glencastle	7 am – 6 pm Mon - Fri
Weir	East	Barton to Britannia	Anytime
Weir	East	Barton to Vansitmart	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Appleford	West	Magnolia to 39.7m northerly	Anytime
Appleford	East	Magnolia to 43.3m northerly	Anytime
Mount Albion	West	Lawrence to Kingswood	Anytime
Mount Albion	West	from 50.3m south of Glen Castle to 150m southerly	Anytime
Mount Albion	East	Lawrence to 200m south of Glen Castle	Anytime
Weir	East	Vansitmart to Britannia	Anytime"

To Amend By-law No. 01-215 and By-law No. 01-218, each as amended <sup>3</sup>

4. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"John East from 22.2m south of John to 5.7m southerly Anytime"

and by adding to Section "E" thereof the following items, namely:

"Bold South from 37.7m west of Pearl to 6m westerly Anytime

John East from 22.2m south of Picton to 5.7m southerly Anytime"

5. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Mount Albion East from 2000 ft. north of Mud to entrance of Glendale Golf Club Anytime"

and by adding to Section "E" thereof the following item, namely:

"Mount Albion Both Lawrence to Hixon Anytime"

6. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"East 34<sup>th</sup> West from 73m north of Crockett to 14.2m northerly 8:00 a.m. to 6:00 p.m. Monday to Friday

7. Schedule 21 (Snow Routes) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:


"Mount Albion Road Mud Street King Street"

and by adding to Section "E" thereof the following item, namely:

"Mount Albion                      Lawrence                      200m south of Glen Castle"

8. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215 and By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
9. This By-law shall come into force and take effect on the date of its passing and enactment.
