CITY OF HAMILTON

BY-LAW NO. 08-220

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Agnes West Argyle to Campbell 1hr Anytime Anyday"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "D" thereof the following item, namely:

"Wills North from 28.7m east of Wilbur to Anytime"
7m easterly

and by adding to Section "D" thereof the following item, namely:

"Wills North from 36.8m east of Wilbur to Anytime"
7m easterly

and by deleting from Section "E" thereof the following items, namely:

"Avondale	West	Barton to Mons	8:00 a.m. to 12:00 Noon 2 nd Thurs each Month April to November
Clark	East	Barton to Ferrie	8 am to 12 noon" 3 rd Tues each Month APRIL - NOV

and by adding to Section "E" thereof the following item, namely:

"Roxborough	North	Glendale to Belview	Anytime"

3. Schedule 10 (Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Dundurn	from 34.4m west of Kenilworth to London	South	North
Roxborough Avenue	Glendale Avenue to Grosvenor Avenue	South	North"

and by adding to Section "E" thereof the following items, namely:

"Dunsmure	from 34.4m west of Kenilworth to London	South	North
Roxborough	Belview to Grosvenor	South	North"

4. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Belview	West	commencing 26 feet south of Cannon and extending 18 feet southerly therefrom	Anytime
Belview	East	commencing 27 feet south of Cannon and extending 16 feet southerly therefrom	Anytime
Edgemont	East	from 10m south of Dunsmure to 5.1m southerly	Anytime
Jackson	South	commencing 99 feet west of Pearl and extending 17 feet westerly therefrom	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Afton	North	from 67.4m east of Lorne to 5.7m easterly	Anytime
Graham	West	from 56.9m north of Maple to 5.5m northerly	Anytime
Province	East	from 12.1m south of Central to 5.5m southerly	Anytime
Roxborough	South	Glendale to Belview	Anytime"

5. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Upper Gage	East	from 143.3m south of Rymal to 37.8m southerly	Anytime"
-------------	------	---	----------

and by adding to Section "E" thereof the following item, namely:

"Upper Gage	East	Rymal to 179m southerly	Anytime"
-------------	------	-------------------------	----------




