

CITY OF HAMILTON

BY-LAW NO. 08-259

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "C" thereof the following items, namely:

"Stevenson East from 28.7m north of Morwick to Anytime"
10.8m northerly

and by deleting from Section "E" thereof the following item, namely:

"Balsam West Afton to Cumberland Anytiem"

and by adding to Section "E" thereof the following item, namely:

"Balsam East Afton to Cumberland Anytime"

and by adding to Section "G" thereof the following item, namely:

"Main North from 12m east of John to Anytime"
13.6m easterly

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Catharine East commencing 106 feet south of Anytime
Murray and extending 22 feet
southerly therefrom

MacNab East from 21.6m south of Burlington to Anytime
5.6m southerly

Northcote East from 121.6m north of Beach Rd. to Anytime"
6.3m northerly

and by adding to Section "E" thereof the following item, namely:

"East 23rd East from 123.2m north of Queensdale to Anytime"
6m northerly

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"Glen South from 52.1m west of Bond to Anytime
36.6m westerly

Ronaldshay West from 55.2m north of Hester to 26.6m northerly 7:00 a.m. to 6:00 p.m.
Monday to Saturday

5. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Magill West from 57m north of York to 10.1m northerly 8:00 a.m. to 5:00 p.m."
Monday to Friday

and by adding to Section "E" thereof the following item, namely:

"Magill West from 57m north of York to 10.1m northerly 8:00 a.m. to 8:00 p.m."

6. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Glen South from 64.6m west of Bond to 38.1m westerly 7:00 a.m. to 6:00 p.m."
Monday to Saturday


and by adding to Section "E" thereof the following item, namely:


"Glen South from 88.7m west of Bond to 15.4m westerly 7:00 a.m. to 6:00 p.m."
Monday to Saturday

7. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.

8. This By-law shall come into force and take effect on the date of its passing and enactment.
