## BY-LAW NO. 10-062

**Respecting:** 

Removal of Part Lot Control Block 1 of Plan No. 62M-1135, "Ancaster Arbour"

**WHEREAS** the sub-section 50(5) of the <u>*Planning Act*</u>, (R.S.O. 1990, Chapter P.13, as amended, establishes part-lot control on land within registered plans of subdivision;

AND WHEREAS sub-section 50(7) of the *Planning Act*, provides as follows:

"(7) **Designation of lands not subject to part lot control.** -- Despite subsection (5), the council of a local municipality may by by-law provide that subsection (5) does not apply to land that is within such registered plan or plans of subdivision or parts of them as are designated in the by-law."

**AND WHEREAS** the Council of the City of Hamilton is desirous of enacting such a by-law with respect to the lands hereinafter described;

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Sub-section 5 of Section 50 of the <u>Planning Act</u>, for the purpose of creating 52 street townhouse dwelling units, shown as Parts 1-52 and 54-142 of Plan 62R-18684, shall not apply to the portion of the registered plan of subdivision that is designated as follows, namely:

Block 1, Registered Plan No. 62M-1135, in the City of Hamilton

2. Sub-section 5 of Section 50 of the <u>Planning Act</u>, for the purpose of establishing a private condominium roadway, shown as Part 53 of Plan 62R-18684, shall not apply to the portion of the registered plan of subdivision that is designated as follows, namely:

Block 1, Registered Plan No. 62M-1135, in the City of Hamilton

3. Sub-section 5 of Section 50 of the <u>Planning Act</u>, for the purpose of establishing maintenance easements over Parts 54-142 of Plan 62R-18684, shall not apply to the portion of the registered plan of subdivision that is designated as follows, namely:

Block 1, Registered Plan No. 62M-1135, in the City of Hamilton

- 4. This by-law shall be registered on title to the said designated land and shall come into force and effect on the date of such registration.
- 5. This by-law shall expire and cease to be of any force or effect on the 31<sup>st</sup> day of March, 2012.
