## **CITY OF HAMILTON**

### **BY-LAW NO. 10-067**

#### **To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking**

**WHEREAS** *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Parking Meters) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Queensdale North Upper Wellington to 42.3m 2 hr \$1.00"  
westerly

2. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Moxley Both Gatineau to Rideau 1 hr 8 am – 8 am Mon – Sun"  
(24 hrs)

3. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Moxley East Mohawk to Rideau Anytime"

and by adding to Section "E" thereof the following item, namely:

"Arvin	North	Grays to former Hamilton- Stoney Creek boundary	Anytime"

and by adding to Section "F" thereof the following item, namely:

"Arvin	North	Green to former Stoney Creek- Hamilton boundary	Anytime"

4. Schedule 9 (Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "F" thereof the following item, namely:

"Arvin Avenue	From Stoney-Creek Hamilton Boundary to Jones Road	North	South"

and by adding to Section "F" thereof the following item, namely:

"Arvin	Green to Jones	North	South"

5. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Allan	South	from 35.5m east of Harmony to 6m easterly	Anytime

Keith	North	from 16.6m west of Douglas to 6.1m westerly	Anytime
-------	-------	--	---------

Keith	South	from 8.5m west of Douglas to 5.9m westerly	Anytime"

6. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:


"Lucerne	North	from 50 feet west of Holmesdale to 50 feet west of Holmesdale	Anytime"


and by adding to Section "E" thereof the following item, namely:

"Lucerne	North	from 36.2m east of Glenholme to 98.8m easterly	Anytime

8. This By-law shall come into force and take effect on the date of its passing and enactment.
