CITY OF HAMILTON

BY-LAW NO. 10-240

**To Amend By-law No. 01-218, as amended,
Being a By-law To Regulate On-Street Parking**

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Parking Meters) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"King	South	South Branch, John to Catharine	2 hr	\$1.00"

2. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"King	South	South Branch, commencing 122 feet west of Catharine and extending 104 feet westerly therefrom	30 min	8 am – 8am (24 hrs)	Mon - Sun

Nightingale	Both	Ashley to Wentworth	1 hr	8 am – 4 pm	Mon - Fri

and by adding to Section "E" thereof the following items, namely:

“South Oval South Newton to King 2 hr 8 am – 6 pm Mon – Fri
Nightingale Both Steven to Wentworth 1 hr 8 am – 4 pm Mon – Fri”

3. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "C" thereof the following item, namely:

“Grindstone East & South from 48.2m north of the west intersection with Waterwheel to 31m northerly and easterly along the curb line Anytime”

and by deleting from Section "D" thereof the following item, namely:

“Fall Fair Way Both Binbrook to Regional Road 56 Anytime”

and by deleting from Section "E" thereof the following items, namely:

“Catharine West Barton to 125' south Anytime
South Oval North Newton to Marion Anytime
South Oval South Marion to King Anytime”

and by adding to Section "E" thereof the following items, namely:

“Catharine West from 39.8m south of Barton to 23.6m southerly 8:00 a.m. to 6:00 p.m. Monday to Friday
Catharine West Barton to 39.8m southerly Anytime
Edwina North & East from 56.2m west of Edwina Court to 27m westerly and northerly along the curb line Anytime
Newcastle East & South from 72.1m south of Thorner to 27.2m southerly and easterly along the curb line Anytime
South Oval North Newton to King Anytime”

4. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Garside	East	from 51.7m north of Dunsmure to 6.7m northerly	Anytime
London	West	from 41.2m south of Cannon to 6.4m southerly	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Macaulay	North	from 42.4m west of Mary to 6.8m westerly	Anytime
Munn	North	from 8.6m east of Upper Sherman to 5.3m easterly	Anytime"

5. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Lottridge	West	Cannon to Somerset	Mon. – Fri." 4:00 pm-6:00 pm
------------	------	--------------------	---------------------------------

6. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

"Ogilvie	West	from 26.7m north of Hatt to 12.4m northerly	Anytime"

and by adding to Section "E" thereof the following item, namely:


"Inverness	North	Barker to 16m westerly	Anytime"

7. Schedule 15 (Commercial Vehicle Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"King South 29 ft. South branch – 93 Anytime"
ft. west of Catharine

8. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
9. This By-law shall come into force and take effect on the date of its passing and enactment.
