## **CITY OF HAMILTON**

### **BY-LAW NO. 11-011**

#### **To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking**

**WHEREAS** *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Harvey          Both          Sanford to Stirton          2 hr          8 am – 8 am          Mon – Sun"  
(24 hrs)

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "D" thereof the following item, namely:

"Donald Bell          East          Viking to 69 Donald Bell Drive          Anytime"

and by adding to Section "E" thereof the following items, namely:

"Garden          South          from 185.8m west of East 24<sup>th</sup>          Anytime  
& East          to 24.5m westerly and  
southerly along the curb line

Lawnhurst	East & North	from 60.2m south of Lesterwood to 24m southerly and easterly along the curb line	Anytime”

and by deleting from Section "G" (Loading Zones) thereof the following item,  
namely:


"King	North	Red Hill Valley Parkway to Huxley	4:00 p.m. to 6:00 p.m. Monday to Friday

5. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Glen	South	from 47.6m east of Paradise to 4.7m easterly	8:00 a.m. to 5:00 p.m." Monday to Friday

6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
7. This By-law shall come into force and take effect on the date of its passing and enactment.
