CITY OF HAMILTON

BY-LAW NO. 11-216

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Crockett North East 32nd to East 33rd 1 hr 8 am – 6 pm Mon – Sat"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "B" thereof the following item, namely:

"Olympic Dr. South King St. to York Rd. Anytime"

and by adding to Section "B" thereof the following items, namely:

"Newcombe South Davidson to north intersection Anytime
& East with Forest Valley

Olympic Both Cootes to York Anytime"

and by deleting from Section "E" thereof the following item, namely:

“Glendale	East	Cannon to a point 59 feet southerly therefrom	Anytime”

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

“Keith	South	from 8.5m east of Keith to 6m easterly	Anytime
Madison	West	commencing 46m north of Wilson and extending 5.5m northerly therefrom	Anytime
Madison	East	from 53m north of Wilson to 4.6m northerly	Anytime
Somerset	South	commencing 334 feet west of Barnesdale to a point 18 feet westerly	Anytime
Somerset	North	commencing 190 feet west of Barnesdale to a point 20 feet westerly therefrom	Anytime”

and by adding to Section "E" thereof the following items, namely:

“Adams	West	from 43.7m south of Cannon to 6m southerly	Anytime
Division	East	from 3.2m south of the extended north curb line of Merchison to 6m southerly	Anytime
East 37 th	West	from 71.3m south of Concession to 6m southerly	Anytime
East 37 th	East	from 71m south of Concession to 6m southerly	Anytime
Hillcrest	South	from 60.9m east of the extended east curb line of Chedoke to 6.1m easterly	Anytime
Keith	South	from 8.5m east of Douglas to 6m easterly	Anytime

Newlands	North	from 22.9m west of Hope to 5.7m westerly	Anytime
Weir	West	from 105m north of Britannia to 6m northerly	Anytime"

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following items, namely:

"Creekside	South	from 23.3m west of Ogilvie to 6m westerly	Anytime
Creekside	South	from 79.4m west of Ogilvie to 6m westerly	Anytime
Creekside	South-west	from 140.7m west of Ogilvie to 6m north-westerly	Anytime
Creekside	South-west	from 199.8m west of Ogilvie to 6m north-westerly	Anytime
Terrace	South-east	East intersection of Turnbull to 45m southerly	Anytime"

and by adding to Section "E" thereof the following item, namely:

"John	East	from 23.9m south of King William to 35m southerly	Anytime"
-------	------	---	----------

and by adding to Section "F" thereof the following items, namely:

"Avalon	North	Lake Avenue Drive to 39m westerly	Anytime
Avalon	South	Lake Avenue Drive to 22.5m westerly	Anytime"

5. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Somerset	North	from 57.9m west of Barnesdale to 6.1m westerly	Anytime"
