CITY OF HAMILTON

BY-LAW NO. 11-284

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Butler & East	North commencing at Acadia (north leg) and extending to Acadia (east leg)	1 hr	8 am – 4 pm	Mon – Fri"

and by adding to Section "E" thereof the following items, namely:

"Butler	East	from the north intersection with Acadia to 113m southerly	1 hr	8 am – 4 pm	Mon – Fri
Greenhill	East	Vienna to Monte	2 hr	9 am – 5 pm	Mon – Fri"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following items, namely:

and by adding to Section "C" thereof the following item, namely:

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Allan	South	from 68m east of Harmony to 6m easterly	Anytime
Cheever	East	from 76.5m north of Barton to 7m northerly	Anytime
Cheever	West	from 71m north of Barton to 7m northerly	Anytime
Grosvenor	West	commencing 37.8m north of Cannon and extending 6.4m northerly therefrom	Anytime
William	West	commencing 321 feet north of Barton and extending 23 feet northerly therefrom	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Avondale	West	from 69.8m south of Barton to 8.8m southerly	Anytime
Avondale	East	from 69.8m south of Barton to 6m southerly	Anytime
Gordon	South	from 50.3m east of Cavell to 6m easterly	Anytime"

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Wexford	East	Main to 31.5m southerly	Anytime"

and by adding to Section "F" thereof the following item, namely:

"Upper Mount East Artfrank to 18.8m southerly Anytime"

5. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Ronaldshay West from 24.6m north of Hester to 7:00 a.m. to 6:00 p.m."
30.6m northerly Monday to Saturday


and by adding to Section "E" thereof the following items, namely:

"Hester North from 10.5m west of 2:00 p.m. to 4:00 p.m.
Ronaldshay to 34.6m westerly Monday to Friday


Ronaldshay West from 24.6m north of Hester to 7:00 a.m. to 9:00 a.m."
30.6m northerly Monday to Friday

6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
7. This By-law shall come into force and take effect on the date of its passing and enactment.
