To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"East 31st	Both	Munn to Queensdale	1 hr	8 am – 6 pm	Mon – Fri
East 31st	Both	Crockett to Munn	1 hr	8 am – 6 pm	Mon – Fri"

and by adding to Section "E" thereof the following item, namely:

"East 31st Both Crockett to Brucedale 1 hr 8 am – 6 pm Mon – Fri"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Luscombe	North	Upper Wellington to 75 feet west	Anytime
Luscombe	South	Upper Wellington to 125 feet west	Anytime"

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Birch	East	from 53.6m north of Cannon to 5.7m northerly	Anytime
Mary	West	from 38.6m south of Robert to 5.6m southerly	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Allandale	West	from 42.1m north of Britannia to 6m northerly	Anytime
Allandale	East	from 22.8m north of Britannia to 6m northerly	Anytime
Stapleton	West	from 93.2m south of Grenfell to 6m southerly	Anytime
Stapleton	East	From 95.4m south of Grenfell to 10.9m southerly	Anytime"

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:
