BY-LAW NO. 16-276

**To Amend By-law No. 01-218, as amended,
Being a By-law To Regulate On-Street Parking**

WHEREAS Section 11(1)1 of the *Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*,

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Landsdowne	South	Sherman to a point 578 feet easterly therefrom	1 hr	8 am – 6 pm	Mon – Sat
Sherman	East	Landsdowne to Biggar	1 hr	8 am – 6 pm	Mon – Sat"

and by adding to Section "E" thereof the following items, namely:

"Barker	Both	Inverness to northerly end	3 hr	8 am – 4 pm	Mon – Fri
Sherman	East	Landsdowne to Biggar	3 hr	8 am – 6 pm	Mon – Sat"

“Normanhurst West from 76m north of Roxborough to 7m northerly 8:00 a.m. to 4:00 p.m.”
Monday to Friday

7. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
8. This By-law shall come into force and take effect on the date of its passing and enactment.
