BILL NO. 2381

Being a by-law to amend Regional By-law R84-026 as amended, by implementing the 1994 Water and Sewer Rate Report, and update the Water Demand Control Strategy with respect to Swimming Pools and Transfer of Ownership.

WHEREAS the Council of the Regional Municipality of Hamilton-Wentworth on the 16th day of November, 1993 did approve Item 2 of Report 13-93 of the Finance Committee which authorized the 1994 User Fees effective January 1, 1994;

AND WHEREAS the Council of the Regional Municipality of Hamilton-Wentworth on the 16th day of November, 1993 authorized that the appropriate Regional By-laws be changed to reflect the 1994 User Fees.

WHEREAS the Council of the Regional Municipality of Hamilton-Wentworth on the 18th day of January, 1994 did approve Item 8 of Report 1-94 of the Finance Committee which authorized the 1994 Water and Sewer Rates effective January 1, 1994;

AND WHEREAS the Council of the Regional Municipality of Hamilton-Wentworth on the 18th day of January, 1994 authorized that the appropriate Regional by-Laws be changed to reflect the 1994 Water and Sewer Rates effective January 1, 1994;

WHEREAS the Council of the Regional Municipality of Hamilton-Wentworth on the 15th day of February, 1994 did approve to amend subsection h) of Item 8 of Report 1-94 of the Finance Committee which authorized a 1994 Water Demand Control Strategy Update for Swimming Pools;

AND WHEREAS the Council of the Regional Municipality of Hamilton-Wentworth on the 15th day of February, 1994 authorized that the appropriate Regional by-Laws be changed to reflect the 1994 Water Demand Control Strategy Update;

WHEREAS the Council of the Regional Municipality of Hamilton-Wentworth on the 15th day of March, 1994 did approve item 12 of Report 3-94 of the Finance Committee which authorized a 1994 Water Demand Control Strategy Update for Transfer of Ownership;

AND WHEREAS the Council of the Regional Municipality of Hamilton-Wentworth on the 15th day of March, 1994 authorized that the appropriate Regional by-Laws be changed to reflect the 1994 Water Demand Control Strategy Update;

4. That Regional By-law R84-026, as amended, is further amended by changing clause 8(1)(e),

from: on all non-metered properties having swimming pools.

- to: that non-metered properties with swimming pools be exempted from the requirement of having to be metered, but that future installations be exempt only where permits are not required.
- 5. That subsection 10 of Regional By-law R84-026, as amended, be further amended by including a second paragraph, namely:

In the event that the outside reading device registers differently from the meter, the reading on the meter shall be taken to be correct. Therefore, if the reading on the meter is greater than that on the outside reading device, it is the property owner's responsibility to pay for the resulting difference in consumption. However, an amnesty period ending September 30, 1994, will be permitted to all property owners who report a difference between the two readings to the Commissioner of Finance, or his designate.

- 6. That subsection 13(3) of Regional By-law R84-026, as amended, is hereby repealed, and the following substituted therefor,
 - 13(3) Effective January 1, 1994 accounts outstanding longer than twenty-one (21) days after billing will be charged a late payment penalty of 3%.
- 7. That subsection 4(15) of Regional By-law R84-026, as amended, be further amended by changing "except as in 4(13)(c)" to "except as in 4(13)".
- 8. That subsection 4(16) of Regional By-law R84-026, as amended, be further amended by changing "as set out in Section 2 of Schedule 'E'" to "as set out in Section 3 of Schedule 'E'".
- 9. That subsection 4(17) of Regional By-law R84-026, as amended, be changed by replacing "and the rates for water supply shall be as described in Schedules 'G', 'G-1' and 'G-2'" to "and the rates for water supply shall be as described in Schedule 'G'".
- 10. That subsection 9 of Regional By-law R84-026, as amended, be altered from "as set forth in Section 1(b)" to "as set forth in Section 1(c)".
- 11. That subsection 12(2) of Regional By-law R84-026, as amended, be revised from "for which water no rate is payable" to "for which no water rate is payable"; and from "more particularly described in Schedule 'G', 'G-1', and 'G-2'" to "more particularly described in Schedule 'G'".

- 12. That subsection 12(3)(a) of Regional By-law R84-026, as amended, be revised from "as set forth in Section A of Schedule 'G', 'G-1' and 'G-2'" to "as set forth in Section A of Schedule 'G'".
- 13. That subsection 12(3)(b) of Regional By-law R84-026, as amended, be revised from "as set forth in Section B of Schedule 'G', 'G-1' and 'G-2'" to " as set forth in Section B of Schedule 'G'".
- 14. That subsection 12(4) of Regional By-law R84-026, as amended, be revised from "as set forth in Section B of Schedule 'G', 'G-1' and 'G-2'" to "as set forth in Section B of Schedule 'G'".
- 15. That subsection 12(5)(a)(i) of Regional By-law R84-026, as amended, be changed from "as set forth in Schedule 'G', 'G-1' and 'G-2" to "as set forth in Schedule 'G'".
- 16. That subsection 12(5)(a)(ii) of Regional By-law R84-026, as amended, be altered from "the applicable meter rate set forth in Schedule 'G', 'G-1' and 'G-2'" to "the applicable meter rate set forth in Section B of Schedule 'G'".
- 17. That subsection 12(5)(b) of Regional By-law R84-026, as amended, be revised from "pay meter rates as set forth in Section A of Schedule 'G', 'G-1' and 'G-2'" to "pay meter rates as set forth in Section A of Schedule 'G'"; and, from "pay the applicable meter rate set forth in Schedule 'G', 'G-1', and 'G-2'" to "pay the applicable meter rate set forth in Schedule 'G'".
- 18. That subsection 12(5)(c) of Regional By-law R84-026, as amended, be revised from "as set forth in Section 7 of Schedule 'E'" to "as set forth in Section 17 of Schedule 'E'".
- 19. That subsection 12(8) of Regional By-law R84-026, as amended, be revised from "then charges will be made as set forth in Section 4 of Schedule 'C'" to "then charges will be made as set forth in Section 3 of Schedule 'C'".
- 20. That subsection 13(2) of Regional By-law R84-026, as amended, be revised from "as set forth in Schedule 'G', 'G-1', and 'G-2'" to " as set forth in Schedule 'G'".
- 21. That subsection 13(6) of Regional By-law R84-026, as amended, be revised from "as set forth in Section A and B of Schedules 'G', 'G-1', and 'G-2'" to "as set forth in Section A and B of Schedule 'G'".

- 22. That subsection 13(6) of Regional By-law R84-026, as amended, be revised from "as set forth in Section 4 of Schedule 'E' to this By-law and the same fee is to be paid by the owner for turning the water on again as set forth in Section 5 of Schedule 'E'" to " as set forth in Section 6 of Schedule 'E' to this By-law and the same fee is to be paid by the owner for turning the water on again as set forth in Section 7 of Schedule 'E'".
- 23. That subsection 18(9) of Regional By-law R84-026, as amended, be further amended by changing "except as in 4(13)(c)" to "except as in 4(13)".

MISCELLANEOUS RATES FOR WATER

(Referred to in Section 12(6), (7), and (8))

1. <u>Travelling Shows</u>

The deposit required from travelling shows is Two Hundred Dollars (200.00) and the fee for connecting and disconnecting the water is the charge applicable for the size of the meter plus the applicable meter rate as set forth in Section 13 of Schedule "E" to this By-law.

2. Tank Trucks

The rate payable for water supplied to tank trucks at the Region's coin operated stations remain at \$0.656 per cubic meter or part thereof.

Such trucks shall only be supplied at the following locations:

- (i) Norfolk Street (Fire Station), Hamilton
- (ii) Shavers Road, Ancaster
- (iii) Dartnall Road, Hamilton

3. Areas Outside the Regional Area

The rate for water supplied to municipalities for the owner or occupier of any lands outside the Regional area is the applicable meter rate set forth in Schedule "G", plus fifty per cent (50%) surcharge or other such surcharge as may be specifically defined in the Agreement between the Regional Corporation and the municipality, owner or occupier of the lands outside the Regional Area.
