




HOW SHOULD HAMILTON GROW TO 2051?

Hamilton is growing.

The Province of Ontario requires Hamilton to plan to accommodate **236,000 more people by 2051.**

We want to hear from you about how the city will grow. How should Hamilton manage this mandated future growth?

FORECASTED POPULATION GROWTH



INTENSIFICATION & DENSITY ARE IMPORTANT!

If the City plans for **more intensification** and **higher density** development within our existing neighbourhoods in the urban area, it will reduce the amount of new greenfield lands outside of the existing urban boundary needed to 2051.

WHAT IS "GREENFIELD LAND"?

Greenfield land is currently undeveloped land at the edge of the City. It is currently a mix of farmland and rural lands.

WHAT DOES DENSITY OF DEVELOPMENT MEAN?

It is the number of units that can be built on a hectare of land. For example, tall towers would be considered an example of "high density" while single detached homes would be considered "low density". There are also many forms of medium density housing, such as townhouses and low-rise apartments.

WHAT DOES INTENSIFICATION MEAN?

Intensification is the development of new residential units in the City's existing developed area.

HOW CAN THE CITY GROW? There are 2 key choices the City must make:

1

How much of the population and housing growth should be planned for within the city's existing urban boundary through intensification and redevelopment in existing neighbourhoods and communities?

2

How much of the population and housing growth should be planned in new greenfield neighbourhoods and communities located beyond our current urban boundary? The addition of new greenfield lands to the urban area is called urban boundary expansion.

Over the past 10 years, **9,256 intensification units** have been constructed, with an intensification rate of **39%**.
