Re: Monthly Report for the month of November 2021

The Building Division report of building activity for November 2021 is enclosed for your perusal.

In November the Division issued \$90.21 million in building permits. There were 725 building permits and 146 zoning verification/property reports issued.

For the month, the residential component was the strongest accounting for 86.45% of the month's total and is valued at \$77.99 million. Of the 502 permits in the residential category, 134 permits were issued for new single-family dwellings at a total value of \$47.49 million. Commercial activity accounts for 6.33% or \$5.71 million with 43 permits issued. Industrial activity accounts for 4.01% or \$3.62 million and the government and institutional activity accounts for 0.91% or \$0.82 million.

The year to date total of \$2.02 billion in construction value marks the first time the City of Hamilton has reached \$2 billion in construction value within one calendar year. Increases of 77.3% in the ICI and 50.1% in the Residential sectors when compared to the previous 3-year average have significantly contributed to the 2021 milestone achievement.

We trust these comments will aid you in the understanding of this report.
