## BUILDING DIVISION PLANNING & ECONOMIC DEVELOPMENT DEPARTMENT MONTHLY PERMIT REPORT

To Subscribers:

Re: Monthly Report for the month of February 2022

The Building Division report of building activity for February 2022 is enclosed for your perusal.

In February the Building Division issued 510 building permits valued at \$69.15 million.

For the month, the residential component was the strongest accounting for 79.34% of the month's total and is valued at \$54.86 million. Of the 373 permits in the residential category, 120 permits were issued for new single-family dwellings at a total value of \$37.53 million. Commercial activity accounts for 7.26% or \$5.02 million with 30 permits issued. Industrial activity accounts for 5.90% or \$4.08 million and the government and institutional activity accounts for 2.13% or \$1.48 million.

We trust these comments will aid you in the understanding of this report.
