Re: Monthly Report for the month of March 2022

The Building Division report of building activity for March 2022 is enclosed for your perusal.

In March the Building Division issued 644 building permits valued at \$123.78 million.

For the month, the residential component was the strongest accounting for 85.59% of the month's total and is valued at \$105.95 million. Of the 458 permits in the residential category, 96 permits were issued for new single-family dwellings at a total value of \$38.47 million. Commercial activity accounts for 3.03% or \$3.76 million with 37 permits issued. Industrial activity accounts for 5.22% or \$6.47 million and the government and institutional activity accounts for 4.15% or \$5.13 million.

We trust these comments will aid you in the understanding of this report.
