## BUILDING DIVISION PLANNING & ECONOMIC DEVELOPMENT DEPARTMENT MONTHLY PERMIT REPORT

To Subscribers:

Re: Monthly Report for the month of December 2022

The Building Division report of building activity for December 2022 is enclosed for your perusal.

In December the Building Division issued 388 building permits valued at \$82.45 million.

For the month, the residential component was the strongest accounting for 80.34% of the month's total and is valued at \$66.24 million. Of the 282 permits in the residential category, 118 permits were issued for new single-family dwellings at a total value of \$20.73 million. Commercial activity accounts for 8.40% or \$6.93 million with 35 permits issued. Industrial activity accounts for 3.25% or \$2.68 million and the government and institutional activity accounts for 7.42% or \$6.12 million.

For the eleventh consecutive year and twelfth time in the past thirteen years, construction activity within the City of Hamilton exceeded the \$1 billion mark. In 2022 the City of Hamilton recorded a construction value of \$1.86<sup>1</sup> billion, the 2<sup>nd</sup> highest in the City of Hamilton's history.

The residential sector activity remained high with over \$1.3 billion in construction or 73.8% of the annual total. The ICI sector (Industrial, Commercial, and Institutional) generated \$459 million worth of construction with 818 in building permits issued.

We trust these comments will aid you in the understanding of this report.
