There are several projects currently underway in the Planning Division, all of which relate to planning for residential growth in new communities of Hamilton. The projects are:

- The Growth Related Integrated Development Strategy Update ("GRIDS 2") and the Municipal Comprehensive Review ("MCR");
- Secondary Planning in new communities, such as the Elfrida Growth Area Study: and.
- The Residential Zoning Project.

Staff in Planning Division are coordinating a series of Public Open Houses on November 13th, 20th and 22nd, 2018, as per the attached notice. The purpose of these Open Houses is to inform and educate the community on these inter-related projects and their importance in planning for complete communities. The Open Houses will provide members of the public with the opportunity to understand current trends in community planning and zoning, benefits of planning for higher densities, and how higher density communities will look.
