In 2016, the Basic Needs Work Group of the Hamilton Best Start Network put together the first edition of the Basic Needs Financial Supports Catalogue. This catalogue was developed in response to the discovery that several resources available to low-income families that help them with their basic needs were not well known by families and service providers.

This catalogue offers a variety of information about benefits, tax credits and programs which provide some form of financial assistance to those who need it.

Intended to provide a collection of financial resources to help low-income families access and apply for local, provincial and federal income support, this catalogue enables families to take advantage of programs that have been established to be a great benefit to them.

The City of Hamilton, along with the Learning and Mobilization Network, is committed to providing up-to-date information. The catalogue will be reviewed on an annual basis.

The Financial Supports Catalogue is based on the following criteria:

- ✔ Income supports connected to basic needs
- ✔ For children and families; 18 years and younger



Program Name

Canada Learning Bond (CLB)

What is it?

- Eligible families will receive \$500 now and \$100 each year for each child's Registered Education Savings Plan (RESP), until child turns 15 (\$2,000 overall)
- Must open RESP account; \$25 cost is covered through CLB
- Money can be used after high school to help pay for either full- or part-time studies, including apprenticeship program, CEGEP, trade school, college, university

What is required and what do I need to know?

- Primary caregiver must be receiving the National Child Benefit Supplement (addition to the Child Tax Benefit)
- Must have SIN for primary caregiver and child(ren) to apply

Canada Education Savings Grant (CESG)

- Provides 20 cents on every dollar contributed to RESP, up to a maximum of \$500 on an annual contribution of \$2,500
- Grant is available until the end of the calendar year in which the child turns 17



Additional Canada Education Savings Grant (A-CESG)

- Grant money is in addition to any money low- and middleincome families are receiving through the basic Canada Education Savings Grant (CESG)
- Adds an additional 10% or 20% onto the first \$500 or less contributed to the RESP annually
- Money can be used after high school to help pay for either full- or part-time studies, including apprenticeship program, CEGEP, trade school, college, university



What is it?

Destination Clic

- Destination Clic is a summer bursary program for francophone students in Grades 8 and 9 who attend a French-as-a-first language school and live outside of Quebec. Participants in Destination Clic are awarded a \$2,000 bursary (taxable income) that covers tuition fees, instructional materials, meals, and accommodation.
- Applicants must be Canadian Francophone students living outside Quebec.

Institution Funded Special Bursary program (IFSB), Mohawk College

- IFSB is intended to support students with limited income to achieve their first post-secondary certificate or diploma through Continuing Education.
- Students approved for IFSB will be required to pay 25% of their tuition prior to registration. IFSB will fund a maximum of two courses per semester, at 75% of the tuition cost. IFSB may cover up to 100% of book expenses per course.
- Must be a Canadian citizen, receive no other grant or loan from OSAP or assistance from other province, Continuing Ed students pursuing first post-secondary diploma.






